1. The first page of the application **MUST** be signed and dated, whether completed or not. If you prefer, submit credit information on your form or letterhead, but still include the signed Atlas application. If the Atlas application is not signed and dated, we will not be able to complete the approval process.
2. If you send in a standard credit application along with the Atlas form, please make sure your application has all the information required on the Atlas form.
3. Please make sure to complete the sales tax exemption form. Please include resale numbers for all the states that we will ship to. If you prefer, you can also submit your standard resale certificate.
4. If you have been dealing with an Atlas EPS representative, please include that person's name at the top of the Atlas application. This will also help speed the approval and setup process.
